Spotlight on Audrey Jones-Drayton



Audrey Jones-Drayton is the Head of Division, Human Ecology (ag.) at the Samuel Jackman Prescod Polytechnic, Barbados. She holds a trained teachers' certificate with a major in Home Economics from the Lillian Dewar College of Education, Guyana, a Bachelor of Education Degree from the College of Arts Science and Technology, (UTech) Jamaica majoring in Clothing, Housing and Design, a Master of Education Degree in Teacher Education from the University of the West Indies, Mona, Jamaica and post graduate qualifications in Educational Administration from the University of the West Indies, Cave Hill, Barbados. Ms. Jones-Drayton has attended numerous local, regional and international study tours, workshops and conferences for professional development.

Ms. Jones-Drayton began her teaching career over thirty six years ago in her native Guyana but spent most of those years in Barbados. She is well known around the region as a teacher trainer and Home Economics educator having conducted training throughout the Caribbean. She has taught at both the secondary and tertiary levels and is a retired Chief Examiner for the Caribbean Examinations Council examination in Clothing and Textiles.

Ms Jones-Drayton is one of the writers of Home Economics text book series published by the Caribbean Association of Home Economists and is a contributor to their recently published recipe book. She has over the years contributed articles to the CAHE quarterly. She is a member of the International Federation for Home Economics (IFHE) and has been a member of the Caribbean Association of Home Economists Inc. for the past twenty-nine years. She is the current President of the Association.

In addition to her professional activities Ms Jones-Drayton is involved in the Cooperative Credit Union Movement. She also serves on several committees and boards at the community level and within the Church of the Nazarene, Barbados District. Her hobbies are traveling, photography and gardening. •

IFHE UPDATE

Plans are coming together nicely for the upcoming IFHE XXII World Congress to be held in Melbourne, Australia next July 16-21, 2012. The second announcement for the meeting, with details about daily keynote speakers and educational sessions, costs, housing options, and cultural excursions, are included on the Congress website: www.ifhe2012.org. Registration for the meeting is also open on the Congress website, with earlybird registration rates until March 31, 2012. Please note also that the call for abstracts has been extended from September 1 to October 15.

Another thing to note relative to travel to Australia is that all visitors (with the exception of New Zealand and Norfolk Island passport holders), must have a valid visa before boarding their plane regardless of the length of stay and a valid passport is required to apply for a visa. For people holding a U.S. passport the process is very easy. You can apply for Electronic Travel Authority (ETA) by going through the ETA website (www.eta.immi.gov.au/). There is no visa application charge for ETA applications made online, but a service fee of AUD20 is charged for use of the ETA website. Go to the visa section of the IFHE Congress 2012 website for details.

The major work of the International Federation for Home Economics takes place in the Programme and Council Committees of the Federation. Presently there are eight Programme Committees (consumers and sustainable development; food security & nutrition & health; home economics policies in education and training; household technology and sustainability; institutional and hospitality management; international business; outreach to Central and Eastern European countries; and textile and design)

and ten Council Committees (finance/membership; congress; publication and communication; research; young professionals; United Nations; project assessment; IFHE historic documents; think tank; and senior advisory). Involvement of members from the U.S. on these committees varies by year, although it is preferred that people join and remain continually active for a period of at least four years.

Currently there are 12 active members from the U.S. on the consumers and sustainability development, home economics policies in education and training, household technology and sustainability, outreach to Central and Eastern Europe, and textile and design committees. There are also a total of six members from the U.S. on the following council committees: United Nations, project assessment, and senior advisory.

It is likely that there are more people from the United States who are actively involved, but who are not listed on the IFHE database for either of two reasons: they did not pay IFHE dues for 2011 prior to March 31, or they did not go into the IFHE database to update their information. To get into the IFHE database, log into www.ifhe.org/ifhem. I encourage all members of IFHE to seriously think about how you can contribute to this international federation of home economists, and to then join one of these committees. Thanks to electronic technologies today it is possible to be a very involved member without any international travel. Check the IFHE webpage, www.ifhe.org, to find the name of the chairperson of the committee in which you are interested, and then contact that person or the IFHE office, office@ifhe.org, by email. The committee chair will take it from there to get you involved.
