If accepted, these two meetings will become part of the AAFCS program. Do keep in mind that individual members as well as AAFCS communities can submit proposals for Educational Sessions and Events of Interest presentations. Many of you are members of AAFCS, so I encourage you to submit proposals and research abstracts for either oral or poster presentation. Your international endeavors and research would be of interest to the AAFCS membership.

Council Meeting and Research Conference

The 2010 IFHE Council Meeting, to be held in Sligo, Ireland next July, will soon be here. Included with the meeting this time will be a one-day midweek research conference. The theme of the conference is the same as that of the overall Council Meeting, "Vision 2020: Home Economics, Changing Perspectives in a Changing Environment." Information about the Council Meeting, Research Conference, and pre- and post-Council tours can be found on the IFHE webpage, www.ifhe.org.

A call for research papers to be presented at the conference has been announced. This information is also included on the IFHE webpage. Guidelines and Abstract form are included in the announcement. Several important criteria for acceptance of papers are:

1. The first author must be an individual member of IFHE and must register for the Council. A person may submit only one paper as first author.
2. Papers must be previously unpublished.
3. Papers will be selected on the basis of significant merit and relevance to the field of "Home Economics" and should have implications for individuals, families and/or households.
4. Papers must be based on scientific research, aim at development of concepts or theories, and add to the body of knowledge.

Abstracts must be submitted to the IFHE Office (office@ifhe.org) by the deadline of December 1, 2009. Notification of acceptance will be mailed to the first author by February 15th, 2010. •

IFHE Council 2010 to be held in Sligo, Ireland

The International Federation of Home Economics (IFHE) Council 2010 will take place on July 20, 2010 at St. Angela's College in Sligo, Ireland. The theme of this conference will be "Vision 2020: Home Economics, Changing Perspectives in a Changing Environment". The conference will be focused on the three areas of Sustainability, Globalization and Interculturalism. The keynote speakers include:

Dr. Martin Caraher, the Associate Dean/Reader in Food and Health Policy in the Center for Food Policy at City University, London. Dr. Caraher has worked extensively on issues related to food poverty, cooking skills, local sustainable food supplies, the role of markets and co-ops in promoting health, farmers markets, food deserts & food access, retail concentration and globalization.

Dr. Kate Fletcher is the keynote speaker in the area of fashion and sustainability. Dr. Fletcher has been exploring fashion as a positive force for change towards sustainability for the last fifteen years. She has helped develop the concept of 'slow fashion' and has championed innovative approaches to developing sustainable fashion products and services with clients including high street retailers, small design led companies and non profit or-

ganizations. She is the author of the widely acclaimed book, *Sustainable Fashion and Textiles: Design Journeys*.

Dr. Dymna Devine is the keynote speaker in the area of interculturalism and education. Dr. Devine is a senior lecturer in the School of Education, University College Dublin, where she is Director of the Structured PhD program and Chair of post graduate studies. She lectures in the areas of sociology of education, sociology of childhood and qualitative research methods. Chair of the Egalitarian World Initiative (EWI) research cluster on Children's Rights, she was awarded a Marie Curie Fellowship to NOSEB, where she has been appointed as external examiner for research degrees. She has published nationally and internationally in the areas of Childhood Studies and Children's Welfare; Migration, Ethnicity and Schooling; Gender and Education Management and School Effectiveness and Improvement. An invited expert peer reviewer for the European Science Foundation (ESF) for the period 2008-2009, she is currently involved in a number of international research projects in the areas of effective teaching and learning and facilitating migrant parents in schools. •

The IFHE Leadership Meeting will be held at the Telekom Tagundshotel Ismaning in Munich, Germany from February 5-9, 2010. In recent years IFHE-US members who attend the leadership meetings have been few in numbers and as a result USA involvement in the various committees of the Federation has been somewhat limited. With the new focus of the International Federation under the leadership of Dr. Geraldene Hodelin from Jamaica, let us from the United States support her and the Federation by attending this year, and becoming actively involved in the work of this international organization. In addition to a one-day symposium on empowering home economists/family and consumer scientists in the digital world and meeting times for program and council committees, there will be internet workshops on how to create and use a Blog, sightseeing tours around Munich, an opportunity to attend the opera, and an evening at the Munich Hofbrauhaus. If you are concerned about traveling alone, be assured that there will be at least a few other Americans going including the IFHE-US President, Mary Warnock, and me, Joanne Pearson. Do not hesitate to contact us if you have questions.

For the first time people can join the leadership meeting without traveling to Germany. On Saturday, February 6th, the Leadership Meeting will be a one-day symposium "Home Economics beyond 100 years: Empowering for the Digital World." This symposium will be available on the internet as an international web seminar/e-classroom if at least 15 IFHE members around the world wish to take part via internet and submit online registration by December 15th, 2009. There will be no registration fee for joining the symposium via the web. IFHE-US members who are not able to go to Germany for the entire Leadership Meeting are encouraged to sign up for this program. You might plan this as a regional gathering of members, as a district workshop, or include it as a required or optional activity in an undergraduate or graduate course. •

Report from the UNITED NATIONS

The United Nations in New York provides IFHE-US members with a unique opportunity to easily obtain up-to-date information on those issues of concern and under study by the UN and followed by NGO committees. More than ever it is important to be current on issues, particularly those which affect the family.



NEW YORK CITY – WANTED!!! Volunteers for an exciting assignment at the United Nations

IFHE-US has had representatives for the International Federation for Home Economics (IFHE), an international non-governmental organization (NGO), at the United Nations in New York for since 1977. Ruth Norman, the first IFHE representative was appointed in 1977 and was joined by Helen Tarail, as alternate. Soon after Mary McDonald and Rosina Cotruzzola were appointed representatives of AHEA (AAFCS), a national NGOs until 1995 when they retired..

In the 1990's Mary Miller, Mary Covington and Eileen Labiner were appointed. When Ruth Norman resigned in 1999, Mary Miller became the representative and Mary Covington and Eileen as alternates. All 3 are still active. Nora Gorman is a recent representative of AAFCS.

More NGOs for IFHE are needed at the UN. There are committees that are not represented and conferences and briefings that go uncovered. If you want to become a part of this dedicated team and live within commuting distance of New York apply to join them. If you are interested in issues but cannot attend meetings, membership in committees is possible, receiving their minutes and UN related documents.

If you travel to New York and would like to attend a Thursday briefing or a committee meeting, both are possible. More than ever before it is urgent that we remain informed and active in international issues.

UN COMMISSION MEETINGS

Two UN commissions of interest to IFHE are the Commission on Social Development (which includes the family and aging) and the Commission on the Status of Women. Each commission meets yearly in New York and is open to all NGOs.

COMMISSION ON THE STATUS OF WOMEN

From March 1 – 12, 2010 government delegates will be attending the UN Commission on the Status of Women (CSW). The theme will be a 15 year review of the implementation of the Platform for Action resulting from the Beijing Women's Conference in 1995.

Immediately prior to CSW on February 27 – 28 several thousand women from around the world will

attend an NGO Forum – Beijing + 15. As active participants NGOs are a critical element in the commission meeting and have influenced the shaping of policy framework of women's empowerment and gender equality. They also play an important role in helping keep national leaders accountable.

Hundreds of side events are held parallel to the meeting organized by NGOs. During these events women share experiences, discussing issues and developing new strategies.

NGOs have been seriously discussing a 5th world conference to continue the implementation of those issues in the Beijing Platform for Action that have yet to be met. Currently a petition is being circulated by them to urge the UN to hold this meeting.

INTERNATIONAL YEARS

The implementation of the goals of each international year is followed by the UN reports and the NGO Committee meetings with programs related to that year. IFHE representatives to the NGO Committee on the Family are Eileen Labiner and Nora Gorman

FOLLOWUP BY THE UN FOR THE INTERNATIONAL YEAR OF THE FAMILY (held in 1994) July 2009

The highlight of IFHE involvement in the UN was the response of General Assembly to designate 1994 as the International Year of the Family. During that year IFHE organizations, national organizations and individuals around the world presented conferences and a wide variety of activities to highlight and honor the family.

However, any international year also has special meaning for the UN. Each member country is encouraged to make every possible effort to realize the objectives of IYF and integrate a family perspective into national policymaking. A follow-up on the results of these are reported in official documents. The most recent report was submitted in July 2009 and included a summary of the activities implemented by those countries responding. In addition were the findings of an expert

group which held a meeting in Doha on the theme, "Family policy in a changing world: promoting social protection and intergenerational solidarity".

While many issues were addressed, of particular interest to IFHE was the section titled: "Resources, Education and Capacity-building." Included was the following: "In many developing countries...education in family issues and, in particular, family policy is limited...programs such as family studies...are usually non-existent, resulting in a shortage of local family scholars and practitioners...family life education could be introduced at different instructional levels, such as at universities, secondary schools, community centres and hospitals, in order to have qualified personnel to provide...services which would have a focus on the family.

The UN Program on the Family has convened a series of follow up meetings with international NGOs on the contributions of NGOs to the well-being of the family since 1994. The NGO Committee on the Family meets monthly focusing on current family issues.

INTERNATIONAL DAYS

UN International days occur throughout the year. Of particular interest to IFHE members are the International Day of the Family, the International Day of Women and the International Day of Older Persons.

INTERNATIONAL DAY OF OLDER PERSONS

The NGO Committee on Ageing and member states of the UN understand and appreciate the contributions of ageing populations. Their skills, experience and accumulated wisdom have made the world a better place. Failure to recognize their contributions will result in future generations without knowledge of the rich legacy of these pioneers.

The NGO Committee along with several member countries of the UN commemorate the International Day of Older Persons each year on October 8. The theme of the day long meeting was, "Ageing Activism: A Global Tool to Create a Society for All Ages". Emphasized was the interconnection of the world with each country now experiencing a demographic shift in the ageing population. Collaboration is therefore critical in working toward creating a society for all ages.

Addressed in the meeting were strategies to achieve these goals with speakers representing each region of the world. The issues addressed were those of health needs and income security, both aspects of the Millennium Development Goals.

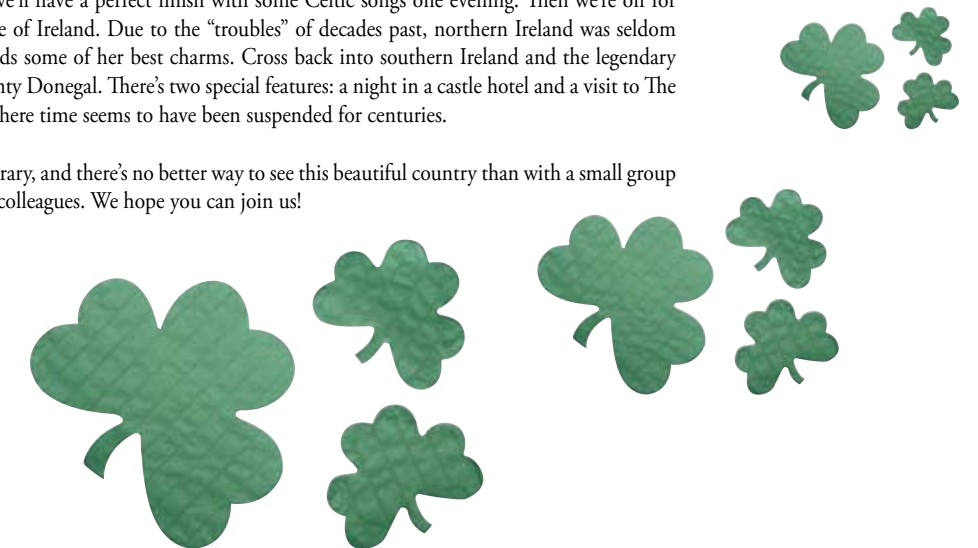
