IFHE SYMPOSIUM 2006

Theme: Households and Families:

Encouragement of Nutritional Knowledge and Skills

The Symposium of the **IFHE Annual Meeting** took place on Saturday 4th February 2006, in Berlin Germany. The IFHE Symposium was funded by the German Federal Ministry for Food, Consumer Protection and Agriculture. With the topic "Households and Families: Encouragement of Nutritional Knowledge and Skills" a good foundation for interesting speeches was given.

The first part focused on the nutritional knowledge of Households and Families and the second part on the political role of Households and Families for a healthy nutrition under the umbrella of sustainable consumer behaviour.

Helping nutrition education happen

Ms **Victoria THORESEN**, the Project Manger of Consumer Citizenship Network (CCN) from the Hedmark University College, Norway, opened with a speech on the importance of international networks for consumers regarded under the aspect of nutrition education. She focused on the challenges of nutrition education and how international networks helps nutrition education happen. They stimulate the dialogue between consumers, researchers and educators and function as a channel for information to the public. Furthermore they can

influence authorities and even corporate enterprises. By encouraging new didactical approaches to nutrition education, networks can contribute to raising the profile of the subject and increasing the competence of the teachers.

Socio cultural values of families from an African perspective

Mrs. **Nwakego MOLOKWU**, Associate Professor of Ahmadu Bello University, Nigeria and IFHE Vice President Africa provided an insight into the importance of socio cultural values of African families and their influence on the nutrition behaviour. She described the role and the changes of African culture, functions of families, the marriage and family system and the importance of kinship. She centred the collapse of family values which are constantly challenged by external influences, especially by new waves of ideas from the western culture. Today youths gain more and more independence, family members are scattered which hampers implementation of family obligations and mutual aid and assistance. But because traditions and culture are the guide to living in Africa, many people resist to the novelties.

In reference to this Mrs. MOLOKWU advises that cultural values should be formed in a way that will promote sustainability in the social, economic and environmental issues.

The significant responsibility of consumers

Prof. Dr. Edda **MÜLLER**, Chair of The Federation of German Consumer Organisations – Verbraucherzentrale Bundesverband, Berlin pointed out the importance of consumer behaviour in Germany and the responsibility for their decisions regarding healthy nutrition. Consumers have to understand that their decisions do not only affect themselves, but also the environment and for the social conditions of production - locally, nationally, and internationally. As regards diet and nutrition, this means that consumers must recognize what a healthy diet is and translate this knowledge into action.

By having such significant function consumers must have the access to information that allows them to make considered decisions. Regarding this aspect it is important that not only NGO`s but even government and industry distribute information.

Consumer education enables people to acquire information, to organize it and to translate the knowledge they have gained into action.

Households as producers and their role for Sustainable Development

Mr. **Stefan EDMAN**, member of Environmental Advisory Council of the Ministry of the Environment and Natural Resources, Sweden, explained the context of way of life of families and the effect on living conditions. Responsibility for a

healthy nutrition and a healthy environment premised, Mr EDMAN pointed out, that people including families recognize the values of nature. In the long term sight, healthy nutrition is not possible without sustainable development. If people have a better understanding of the biological and ecological interaction, they will be more responsible for their own life. A better understanding of the natural conditions, knowledge of healthy food and skills for preparing healthy meals are basic requirements for families to make the right decisions as consumer act as responsible citizen in the sense of sustainable development.

Mr EDMAN referred to the responsibility of all decision makers, who are involved in the food chain and in nutrition processes. Starting with farms, food industries, restaurants, canteens and in particular school meals and communal feeding at all levels, people should take responsibility for healthy nutrition and sustainability.

IFHE ANNUAL MEETING 2006, Berlin

First time in Berlin, Germany

For the first time the **IFHE Annual Leadership Meeting** took place in the Capital City of Germany - Berlin. Under the leadership of IFHE President Lilha LEE 87 IFHE members from 20 different countries all over the world met in Berlin. During the Plenary session IFHE President Lilha LEE presented

the current activities of IFHE and highlighted the main themes and aims of IFHE.

Under the leadership of the Programme Committee International Business Group the Chair Ruth GIBBONS, United Kingdom and Dr. Julia FAUTH, TNS Germany, an IFHE future orientated Strategic Workshop was conducted in Berlin. Based on the results of the IFHE Survey - conducted and sponsored in 2004 by TNS - the participants discussed in 13 different workshop groups strategies to improve the communication and interaction between IFHE Committees and IFHE members and the challenges to increase IFHE memberships. Ms LEE summing up stated the most important aims for IFHE is to offer the best possible services and communication facilities, so that IFHE members from all over the world are motivated to take the chances of international professional networking, to get involved in IFHE activities and to promote Home Economics Education world wide.



The Swiss Congress organisation Committee reported on the current status of the preparation for the XXI IFHE World Congress 2008 in Lucerne, Switzerland. They presented the above showed IFHE Congress Logo 2008.

The IFHE Executive Committee met in Berlin to discuss important topics for the IFHE Council 2006 and the different IFHE internal projects. Prof Dr. Elisabeth LEICHT-ECKARDT and her former student Petra WEHMEIER introduced the first steps of the quality management system, which had been implemented in the IFHE Office to optimise communication and administration processes.

The Executive Committee decided to continue with the implementation of the quality management system in the IFHE organisation.

IFHE PC OUTREACH TO CENTRAL AND EASTERN EUROPE

Grant Obtained from the Monsanto Fund to Aid Children in Moldova

Three NGOs with headquarters in the United States, Germany and the Republic of Moldova have recently received funding for a project entitled "Improving Nutritional Health with School Gardens in Moldova" from the Monsanto Fund. The organisations are the International Federation for Home Economics-United States (IFHE-US), the International Federation for Home Economics (IFHE) and "Partenaires" in Moldova, in conjunction with the Technical University of Moldova. Additional funding for nutrition education books and posters for participating schools has been received from IFHE.

The Monsanto Fund is the philanthropic arm of the Monsanto Company. It currently has as one of its four priority areas improving nutritional well-being through agriculture. Other

priority areas are the environment, science education and our communities. The philanthropic goal of the Monsanto Fund is to bridge the gap between peoples needs and their available resources.

This multi-year, 2.5 years, grant is designed to provide a 2-day nutrition and community gardening workshop for science teachers, health teachers, home economics teachers, boarding school administrators, and school food service managers whose schools have expressed an interest in establishing a school and community garden. In the year following the workshop, gardens will be established and tended, produce harvested and consumed in the schools, and excess produce preserved for use in school cafeterias later in the year. Fruit and vegetable consumption in the school cafeterias will be compared in the schools with gardens and those without gardens to data collected in the knowledge and food practices of school-age children.

The project came as the result of efforts of the Outreach to Central and Eastern Europe Programme Committee of IFHE that wanted to provide a tangible effect of their outreach efforts of the last 10 years. This committee includes representatives from the United States who are members of IFHE-US and members from the European Region of IFHE. It is hoped that this project, and others of its type, can be continued here and in other regions of the world by home economists.

Colleagues, this personal statement is meant to give you a glimpse of my professional convictions as a home economist and to solicit your support for job of President of IFHE.

My association with IFHE began in 1984. That was the year that my quest to understand the professional nature of the discipline of Home Economics began. As a young practitioner, I had the job of leading a team in the development of a baccalaureate degree programme in Home Economics education for high school teachers. It was my intention to develop a programme that would be socially appropriate for the Caribbean, personally satisfying for the practitioners and introduce meaningful and fulfilling life opportunities to the clients it was meant to serve My search led me through many discoveries personally and

professionally and ultimately endeared me to IFHE. It is my belief that everybody's life can be made better. Everyone however, requires different focus and level of intervention to achieve that betterment. Home economists must discern the subtleties of human needs and how best to use their special training and sensitivities to help others meet their particular needs, real or perceived.

This characteristic of the field of Home Economics when viewed from a global perspective, I believe, makes it possible for the discipline to be practiced from many vantage points across the five continents and within each continent. This understanding is fundamental for anyone who is desirous of becoming a leader in IFHE. It is this uniqueness yet commonness that must enamor any leader of this world Federation. Steps to LOG into the IFHE members only area:

The most important precondition for the login to the IFHE Members only area is the correct e-mail address in the IFHE database. If we do not have the correct e-mail address, the login system will fail.

1. step: Open the IFHE database homepage (www.ifhe.org/ifhm)

2. step: Click the LINK "REQUEST LOGIN DATAS"

3. step: Please fill in the pop up form and click **Request**

4. step: you will receive an e-mail with the password (a combination of numbers and letters).

5. step: open the IFHE home page (www.ifhe.org) Enter your personal data in the marked fields on the IFHE home Page "e-mail address" and "password"

6. step: click the sign "lock" and the members only area should be open.

7. step if wanted, you can change the sent password in the IFHE database www.ifhe.org/ifhem, enter the requested data and click "to mainmenu". Your personal data page will open, there you can change your personal password and update your data.

If the procedure will not be successful, the IFHE office might not have your current e-mail address. In case of failure, please contact the IFHE office immediately and we will correct the fault.

YOUNG PROFESSIONALS ANNUAL LEADERSHIP MEETING 2006 IN BERLIN

At the **IFHE Annual Leadership Meeting 2006** a large number of enthusiastic young people met in the frame of the "Young Professionals Council Committee" established at the Annual Leadership Meeting in Bonn, 2005. The committee reflected on the previous years work by the Committee to establish the Young Professionals Network (YPN): the aims, objectives, short term goals have all been achieved. The work of the next year was discussed, with focus on the current term setting objectives that will culminate at the Congress in Lucerne, Switzerland 2008.

In 2005 the primary steps of YPN have mostly been taken place in Europe. Much has been achieved: it has been possible to set up a YPN area on the IFHE website as well as the production of resources to aid the promotion of YPN (information leaflet,

digital presentation – all available on demand). Further, links have been established between IFHE members and young professionals in the support of the network either via regional young professional groups or universities. The most exciting part has been the organisation and facilitation of several meetings on a European regional level. This benchmark model will feed into the international community.

2005 was a year of planning, 2006 a projected year of action, followed by consolidation in 2007 and reflection 2008.

For the year of action 2006 the focus will be to: Develop a network list of attendants of the meeting in Berlin to ease communication. It will be amplified through the year to all YPN members and will be made available in the members only area of the IFHE website in the next few weeks. Some members of the YPN will attend the IFHE Council 2006. An important project for 2006 is the implementation of a mentoring programme. This mentoring will be in two parts: 1. Young Professionals as mentors for new members, simplifying the access and 2. Mentors for Young Professionals with mentor guidelines for a sustainable development of YPN.
